

Guest Waiver of Liability Form

You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities associated with the **Greystone Community Pool**.

Please understand and recognize that lifeguards are not responsible for providing supervision or assessing your swimming skills or that of your minor child; rather, lifeguards are responsible for enforcing safety rules and responding to emergencies. Adult members and/or parents of minor pool members are solely responsible for supervision of any and all activities at or around the pool. Additionally, children 10 years of age and younger must be supervised at all times by a responsible person, 16 years of age or older.

Swimming and other aquatic activities are inherently risky and there is always a risk of serious injury, including but not limited to drowning and head/brain injury. The very nature of swimming and aquatic activities are hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, failing to follow rules and regulations, failure of lifeguards to locate victims and/or delay in emergency response time striking the bottom or side of the pool, inadequate supervision or instruction, slip and falls on the deck, chemical exposure and all other circumstances inherent to aquatic activities. In this regard, it must be recognized that it is impossible for the **Greystone Community Pool** to guarantee any member's safety. Please read this form carefully and be aware that in consideration for this pool membership, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with use of **Greystone Community Pool** and its aquatic facilities.

I recognize and acknowledge that there are certain inherent risks of physical injury to patrons of aquatic facilities, and I voluntarily agree to assume the full risk of any injuries, damages or loss, regardless of severity that my minor child/ward or I may sustain as a result of participating in any and all activities and programs connected with or associated with this membership. I further recognize and agree that lifeguards and other aquatic staff are not responsible for supervising my activities or the activities of my minor child(ren) and I agree that I am solely responsible for supervising my minor children and/or assessing whether my children are physically fit and/or adequately skilled for aquatic activities. I additionally agree to supervise any children I bring who are 11 or under at all times. I further agree to waive and relinquish all claims I, or my minor child/ward may have (or accrue to me or my child/ward) as a result of use of the aquatic facilities and programs against the **Greystone Community Pool**, including its directors, officers, agents, volunteers and employees (hereinafter collectively referred as "Pool and Personnel"). I do hereby fully release and forever discharge the Pool and Personnel from any and all claims for injuries, death, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with use of the Greystone Community Pool's aquatic facilities and grounds.

I do hereby release on my behalf and on behalf of my spouse, children and our respective heirs, assigns and personal representatives, all of our rights to sue **Greystone Community Pool** and its directors, officers, employees, agents, and assigns (hereinafter referred to as 'RELEASED PARTIES') for personal injuries, property damages, or wrongful death and lost consortium that may result from activities at the Greystone Community Pool, including but not limited to the inherent risk associated with swimming or a result of negligence of released parties or any other party. This document will be used in a court of law if you sue any released party or person.
